12	Fischer, Hyde-Smith, Stabenow, Leahy, Klobuchar, Bennet,
13	Gillibrand, Donnelly, Heitkamp, Casey, and Smith.
14	OPENING STATEMENT OF CHAIRMAN ROBERTS
15	Chairman Roberts. Seeing that a reporting quorum is
16	present, I now call to order a business meeting of the
17	Senate Committee on Agriculture, Nutrition, and Forestry.
18	The purpose of this meeting is to consider the
19	nomination of Dr. Mindy Brashears for the position of Under
20	Secretary for Food Safety; the nomination of Mrs. Naomi Earp
21	for the position of Assistant Secretary of Agriculture for
22	Civil Rights; and the nomination of Dr. Scott Hutchins for
23	the position of Under Secretary for Research, Education, and
24	Economics.

Their individual and collective experience, combined

- 1 with their written responses to the members' questions for
- 2 the record show that these nominees are abundantly qualified
- 3 to lead the USDA and tackle the challenges that lay ahead of
- 4 them. I fully support all three of the nominations.
- I now recognize the Ranking Member for any comments she may have.
- 7 OPENING STATEMENT OF SENATOR STABENOW
- 8 Senator Stabenow. I understand you are going to want
- 9 to do voice votes, which is fine with me.
- 10 Chairman Roberts. That is correct.
- 11 Senator Stabenow. I am going to record a no on--
- 12 Chairman Roberts. On the voice vote.
- 13 Senator Stabenow. Yes, on the voice vote.
- 14 Chairman Roberts. Thank you.
- 15 Senator Stabenow. On the nominee on Earp. I am
- 16 waiting to see, I may not -- I may support her on the floor,
- 17 but I have concerns given the seriousness of this position.
- 18 Chairman Roberts. We can send her to you at your
- 19 request.
- 20 Senator Stabenow. So I will be voting no or want to be
- 21 recorded as no on that nominee.
- 22 Chairman Roberts. Okay. I understand that.
- 23 Understanding there is a desire to report these
- 24 nominations individually, we do so in three separate votes.
- 25 A motion will be now in order to approve the nomination of

- 1 Dr. Mindy Brashears--
- Senator Grassley. Do it en bloc.
- 3 Chairman Roberts. --for the position of Under
- 4 Secretary of Food Safety.
- 5 Senator Stabenow. So moved.
- 6 Chairman Roberts. Thank you. Is there a second?
- 7 Senator Grassley. Do it en bloc. Cannot you do it en
- 8 bloc?
- 9 Senator Thune. Second.
- 10 Chairman Roberts. All those in favor, say aye.
- [Chorus of ayes.]
- 12 Chairman Roberts. All those opposed, say no.
- [No audible response.]
- 14 Chairman Roberts. The ayes have it.
- 15 The nomination of Dr. Brashears is approved.
- 16 Senator Grassley. Can you do it en bloc?
- 17 Chairman Roberts. No, not yet.
- 18 Senator Grassley. Okay.
- 19 Chairman Roberts. You can talk to Senator Collins
- 20 later. If you could help me get from page three to page
- 21 four, it would be helpful. Thank you.
- Now a motion would be in order to approve the
- 23 nomination of Mrs. Naomi Earp for the position of Assistant
- 24 Secretary of Agriculture for Civil Rights.
- 25 Senator Ernst. So moved.

- 1 Chairman Roberts. Is there a second?
- 2 Senator Thune. Second.
- 3 Chairman Roberts. All those in favor, say aye.
- 4 [Chorus of ayes.]
- 5 Chairman Roberts. All those opposed, say no.
- 6 [Chorus of noes.]
- 7 Chairman Roberts. The ayes have it and the nomination
- 8 of Mrs. Earp is approved.
- 9 Senator Stabenow. I think there are people who want to
- 10 be recorded as no.
- 11 Chairman Roberts. All those who would like to be
- 12 reported as no--there are four right here, five, six. If
- 13 there is any more....
- 14 [Pause.]
- 15 [Those wishing to be recognized as voting no: Senators
- 16 Stabenow, Leahy, Klobuchar, Bennett, Gillibrand, Donnelly,
- 17 Casey, and Smith.]
- 18 Chairman Roberts. Finally, a motion would be in order
- 19 to approve the nomination of Dr. Scott Hutchins for the
- 20 position of Under Secretary for Research, Education, and
- 21 Economics.
- 22 Senator Stabenow. So moved.
- Chairman Roberts. All those in favor, say aye.
- [Chorus of ayes.]
- Chairman Roberts. All those opposed, say no.
