- 3 the Chairman or Ranking Member is not officially appointed
- 4 by the Senate.
- 5 Pursuant to the agreement, I now recognize Senator
- 6 Stabenow for any remarks she would like to make and for her
- 7 to frame a motion to report the nomination.
- 8 OPENING STATEMENT OF SENATOR STABENOW
- 9 Senator Stabenow. Thank you, Senator Boozman for
- 10 working with me and with all of us to move this forward.
- I strongly support Secretary Vilsack for this
- 12 nomination.
- I would move the nomination of Thomas J. Vilsack for
- 14 the position of Secretary of Agriculture.
- 15 Is there a second?
- 16 Senator Boozman. Second.
- 17 Senator Stabenow. All those in favor, say aye.
- [Chorus of ayes.]
- 19 Senator Stabenow. Those opposed, say nay.
- [No response.]
- 21 Senator Stabenow. The ayes have it.
- The nomination of Thomas J. Vilsack to be Secretary of
- 23 Agriculture is approved.
- 24 [Applause.]
- 25 Senator Stabenow. The Committee is adjourned.
